Tax Free Shopping

For 2017, the total volume of tax-free shopping is forecast to exceed € 52 billion in Europe. The number of nights spent in Germany by travellers from China alone is more than two million per year. Take advantage of this and enable your foreign customers to use the Concardis tax-free function for great prices – without any additional effort on your part.

With the Concardis tax-free function, the tax-free form is created while the payment is being processed – regardless whether payment is in cash or by credit card. After payment, non-EU citizens will receive a slip showing the amount of VAT to be refunded. The only prerequisites are that the customer may not spend longer than six months in the EU and the purchase must have been for greater than €25. When the non-EU citizen then leaves Germany, they will receive

the VAT percentage from their purchase back as a refund. For your customers, this means a savings of up to 19 per cent – one more reason to shop with you. For you, this also means no more filling out slips by hand.
